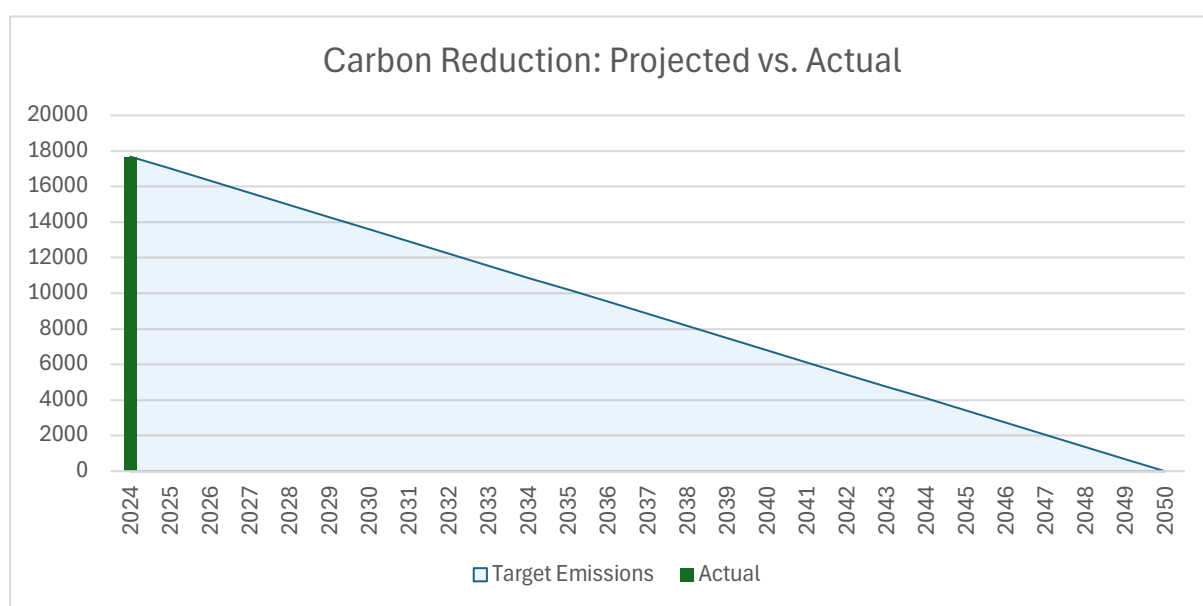

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **14,283 tCO₂e** by 2029. This is a reduction of **19.2%**

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline and the measures will be in effect when performing the contract.

- We have installed an on-site solar PV system to reduce electricity-related emissions through using renewable electricity.
- We are working with our electricity suppliers to proactively procure and use renewable energy.
- We use solar-powered lights and set timers for on-site lighting.
- We have installed and are using energy-efficient solar water heaters and air source heat pump water heaters in staff apartments.
- We are paperless.

- We currently use recyclable paper packaging, and plan to gradually increase the proportion of recyclable and recycled materials in our packaging in the future.
- We plan to implement the ISO 14001 Environmental Management System certification.
- We plan to gradually implement the electrification of our fleet.
- We plan to replace the kitchen (for company cafeteria use) facilities with energy-efficient ones.
- We plan to gradually increase the solar PV system capacity and raise the proportion of renewable energy in purchased electricity.
